## Secretary's Report: Highlights of Board Meeting: April 23, 2010

President Jim Keene called the meeting to order at 5PM. Director Mark Burbic, Director Lew Spangler and Past President John Newbold was not present. Members present included Jim Harris #5010, Ali Kerekes #12901, Dave Broadbent #12791, Ted Hamilton #4298, Georgette Keene #13149, Gerald Stip#3341, Amy Cupples, Joyce Joyner, Angie Gaskins, Melissa Cavins, John Cavins#11441, and Patti Metzgar. Betsy Gwynn, Guidance Counselor from Cape Hatteras High School was our guest. Carol Mowers made a motion to accept the minutes from the March 20, 2010 BOD meeting as written. Mike Metzgar seconded. Motion passed.

Treasurer Brenda Outlaw presented the treasurer's report. Current net assets are \$171,630.00. Director Mike Metzgar presented the current budget. President Keene wanted UMS removed from the budget and all scholarships under one heading.

Member Rod Palmer # reported everything was ready for Operation Beach Respect and Adopt-A-Highway for April 24, 2010. Rod was congratulated on a great job taking over OBR.

Director Mowers reported she will be doing registration at the 4-Plus Tournament on April 24, 2010. Nothing to report at this time on the photo contest.

President Keene reviewed the dates for the DEIS Public Comment Hearings. He will be attending all of the meetings. Vice President Joyner will attend the meeting in Hampton, VA.

Director Mike Metzgar reported on the selected scholarship candidates. He also reported the 2010-2012 election balloting is up and running, constant contact is up and running with information on the DEIS, Red Drum Tournament, voting and the annual meeting. Director Metzgar and Editor McNichol continue to move forward on the newsletter going electronic.

Director Laura Davis reported t-shirt sales are going fine. She will not be re-ordering mock neck turtle neck shirts or the official tan NCBBA standard shirts with the blank back as these have not sold well. She is hoping to have canvas bags available for the annual meeting in general sales are going well.

Member Pete East provided a written report on public relations which was read by Secretary Oates. He placed a public service announcement in the local media about the upcoming OBR's, annual meeting and fall picnic.

Nothing to report on Junior Membership. Articles for the newsletter are due by June 13, 2010 to Editor Mike McNichol.

Nothing to report on fundraising. VP Joyner reported the DEIS was the most important issue before the board.

President Keene reported the status of the TCP's has not moved since his last meeting with Mike Murray over a month ago. Mike Murray did promise that an ethnographic study would be done. To date President Keene has not talked to

anyone who has been interviewed for this study by the Park Service.

President Keene reported on the turtle study done by Bob Davis and Larry Hardham that will be turned into the Park Service along with the Coalition for Beach Access Report. He also encouraged everyone to make as many comments on the DEIS as you want but be specific and follow the Park Service procedure on commenting. The deadline for public comment is May 11, 2010. All three requests for an extension on the deadline were denied.

Treasurer Outlaw will run a query to determine the Achiever of the Year Award. The Award will be presented at the Annual Meeting by Director Mowers.

Director Mike Metzgar reported on the spring UMS meeting. The minutes from the meeting were distributed to the board members. The President & Vice President of UMS will not be re-running for office. UMS have been in discussion on where they can assist and support the access groups. Summer meeting will be in July in New Jersey. The 2010 NCBBA delegates to UMS are VP Dave Joyner, Director Mike Metzgar, Director Carol Mowers, Secretary Tracey Oates, President Jim Keene and Director Laura Davis.

Chairperson of the election committee Tracey Oates reported that the ballots are coming in both by snail mail and e-mail. Some ballots are coming in that have voted for all 5 Director candidates.

These votes are void. The program will be changed for future elections to avoid this problem.

Treasurer Outlaw reported she has not heard back on the progress of the audit. She has completed the form to apply for the North Carolina State License.

President Keene reported the OBPA calendars are ready and are for sale on-line and at the 4 Plus tournament. May 8 2010 there will be a rally in Buxton on the DEIS.

The discussion on the Little Hatteras Tournament 2011 was tabled again until Director Mark Burbic can attend a meeting. No citation report.

Nothing to report on the 50th Anniversary Party. President Jim Keene volunteered to be on the committee.

Vice President Joyner reported that applications for the Red Drum Tournament are slow to come in and we have received the permit from the NPS to hold the tournament. The hat design will stay the same. The shirt design will be a little different this year.

Director Davis went over the action plan for the Annual Meeting. Everything is on schedule. She reviewed the program agenda order, special invitations, contributions, raffles, auction and donations.

Motion to adjourn made by Vice President Joyner, director Davis seconded. Meeting adjourned 8:50PM.

## CHAPA Offers \$1,000.00 Reward for Information about Sea Turtle Fatality on Ocracoke

CHAPA (NCBBA, OBPA & CHAC) are offering this reward for information leading to the arrest and conviction of the person or persons responsible for the death of a nesting female loggerhead turtle that was struck and killed by an off-road vehicle (ORV) during the night-time hours between 10:00 PM, June 23 and 6:00 AM, June 24. The turtle crawled out of the ocean and attempted to lay a nest between Ramps 70 and 72 on Ocracoke Island. The turtle was hit by an ORV and dragged approximately 12 feet, causing fatal injuries to the turtle. The animal was found dead by NPS turtle patrol at 6:10 a.m. on June 24. It is the first ever documented incident of a nesting sea turtle being killed by an ORV at the Seashore. Loggerhead turtles are protected under the Endangered Species Act. If anyone has any information about this incident, please call the Dare Community Crime Line at 252-473-3111.

## NCBBA's Reaction to Sea Turtle Fatality on Ocracoke

NCBBA is outraged by this deliberate act and urges NPS law enforcement rangers to use all available resources to find and apprehend and prosecute to the fullest extent of the law the person or persons responsible.

The environmentalists (DOW, SELC & Audubon) who want to close our beaches have responded to this incident by calling for a lock down of the seashore from sunset to sundown. Instead of offering a reward of their own or condemning this deliberate act of vandalism,

they use this terrible tragedy as another step to further their agenda of turning Cape Hatteras National Seashore Recreational Area into a gated community to which we the taxpaying public have no access. Common sense, not irrational reactions, should prevail.

Installing barriers will not stop those that intend to break the law and would only cause lawbreakers to drive around the barrier doing more damage to the dunes. Locks only keep honest folks honest; those that plan to break the law will do so!

NCBBA has always encouraged NPS to enforce those regulations they have, not make more they are unwilling to enforce. Where was NPS enforcement during the nighttime hours during which this incident occurred? Under the terms of the court ordered consent decree the only vehicles allowed on the Seashore during those hours are NPS. This should have been enforced. Do not punish the general law abiding public for the unlawful action of one or two individuals. Until an arrest and conviction have occurred, no one knows who committed the crime and to blame, try, convict and punish the Access Community is premature. During Reg/Neg the Access Community continually requested that parked vehicles be allowed on the beach during the night time driving ban hours and we were refused. If this had been allowed, surely someone would have been on the beach to witness this unlawful act if it would have even occurred.

NCBBA and other like minded organizations and individuals continue to advocate for reasonable and responsible ORV use, not the restrictive use now in effect.

These very restrictions are the likely cause of this event. Only someone trying to conceal their presence on the beach by trying to drive without headlights could miss something the size of a Loggerhead turtle. Another unintended consequence of the "consent decree"?

# Editorial

In my brief tenure as Newsletter Editor I have observed your NCBBA BOD has become a cohesive group whose primary mission today is to maintain 'Free and Open Access' to CHSNRA beaches.

In the past your Association has raised and solicited funds to support local community agencies, fire companies, food banks and students in need among others. The actions of the Defenders of Wildlife, The National Audubon Society, the Southern Environmental Law Center and the US Fish and Wildlife Service have 'Free and Open Beach Access' becoming endangered and likely extinct on the Outer Banks, all behind the shield of conservation.

Today our right to use our beaches is under assault by well funded environmental groups whose

"war chests" have millions of dollars to fund lawsuits. By necessity your organization has become more aware of the fundraising aspects. NCBBA as a member of CHAPA successfully challenged Fish and Wildlife's designation of Cape Hatteras as "critical overwintering habitat" in 2005 and recovered \$150,000 spent by CHAPA defending the lawsuit. NWS has refilled and again we are challenging this ruling. In the months and years ahead we must continue to fight for access to our beaches for our children and grandchildren but we have little hope unless we can begin to build our own war chest.

Over the next month NCBBA will investigate an Electronic Funds Transfer system enabling members to have regular monthly donations drafted automatically. Regular contributions of

small amounts from a number of people can add up quickly. You may consider NCBBA in your will or as a beneficiary on a life insurance policy for a small percentage of the proceeds. If you have an asset that has appreciated substantially over the years (like those 1000 shares of Apple you bought years ago) and would take a hit on capital gains you may consider donating such assets to a Charitable Remainder Trust with NCBBA as beneficiary. The trust would liquidate the asset and fund a trust that pays you a monthly income for life with any balance remaining going to NCBBA at your passing. The best part is NO capital gains so you receive the full value and the entire amount is deductible as a charitable contribution! It's a win for both parties. This is not meant to be legal advice in any regard. You would need a qualified

attorney to handle these transactions.

An example of this is Audubon's tract of land on the northern Outer Banks that was donated to them for a bird sanctuary about 20 years ago. It is now for sale to a developer for \$25,000,000 to build an oceanfront hotel, condos and retail space. According to Audubon the site "has no conservation value". To be able to defend our access we will need member support in the form of contributions to our legal fund. We can expect a flurry of lawsuits to defend after the final Environmental Impact Statement and the Final Rule is announced. Please consider donating to the legal fund. Who in there right mind would expect to catch strippers in the surf at Oregon Inlet the end of May? Be that as it may, Todd Lewis, #12821, and I were fishing there catching nice black drum in the five to eight pound range on shrimp when his rod really bows up.
