Jim Keene, your BOD & Cape Hatteras Access Preservation Association (CHAPA) has been busy working for beach access. On June 19th our efforts paid off when Congressman Jones office released the following statement:

JONES HATTERAS BEACH ACCESS BILL PASSES THE HOUSE
Jun 19, 2012 Issues: **Energy Environment and Public Lands**

WASHINGTON, D.C. - Today the House passed Congressman Walter B. Jones' bill - The Preserving Access to Cape Hatteras National Seashore Recreational Area Act. The bill was rolled into a package of 13 other bills and voted on as H.R. 2578 - the Conservation and Economic Growth Act. Congressman Jones' bill would restore taxpayers' right to reasonable

pedestrian and motorized access to Cape Hatteras National Seashore Recreational Area. H.R. 2578 passed the House by a vote of 232-188, and now goes to the Senate for further consideration.

"This legislation is about jobs, it's about the taxpayers' right to access the recreational areas they own, and it's about restoring balance and common sense to National Park Service management," said Jones.

Jones' bill would overturn a final rule implemented by the Park Service earlier this year that excessively restricts taxpayers' access to Cape Hatteras Seashore, and is unnecessary to protect the wildlife. The language would reinstitute the Park Service's 2007 Interim Management Strategy to govern visitor access and species protection at Cape Hatteras. It would reopen 26 miles of beach that are now permanently closed to motorized beach access, and give seashore managers flexibility to implement more balanced measures that maximize both recreational access and species protection. By doing so, the bill would reverse the significant job loss and economic decline that Hatteras Island has experienced since the Park Service cut off access to the most popular areas of the seashore.

There is broad, bipartisan public support for this effort. Senators Richard Burr (R-NC) and Kay Hagan (D-NC) have introduced the same bill in the Senate. The bill is also supported by national sportsmen's groups including the American Sportfishing Association and the Congressional Sportsmen's Foundation.

The passage of this bill is the result of direct involvement from you the membership who took the time to contact your elected representatives. I'm sure you grow tired of the Constant Contact e-mails asking you to act, but it was your actions that paved the way for this bill's passage. We must keep the pressure on. By the time you read this the Senate sub-committee will have held their hearing June 27th on S 2372. It faces an uphill climb in a Democratic controlled Senate. Folks are campaigning now for the November elections. Ask them what their stance is on "public access to public lands?" Then vote accordingly.

Enough of my mindless ramblings summer is here. Let's all go to CHNSRA to enjoy our seashore recreating responsibility however you and your family desire. See you on the beach!

A Small Victory for the good guys!!!

The US House of Representatives (HR 4094) and the US Senate (S 2372) have begun a long overdue movement toward our ultimate goal of "Reasonable Management" as opposed to the insane policies currently dictating activities within our beloved "Recreational Area".

The House of Representatives, Committee on Natural Resources, has cleared the Walter Jones bill (HR 4094) for a floor vote as a part of HR 2578. When this vote will occur is not known at this time but may be scheduled as early as the latter part of July. Congressman Jones and his staff deserve a resounding thank you for the work done in preparing and presenting this legislation. We ask for his continued efforts in presenting this bill to the full membership in the House of Representatives.

The Senate's Energy and Natural Resources Committee held a hearing (June 27) on the bipartisan companion bill, S.2372 co-sponsored by NC Senators Burr (R) and Hagan (D). Warren Judge, Chairman of the Dare County board of Commissioners, articulated the position of access being the central issue and how the excessive closures currently in place are damaging both visitor experience and the business climate within the county. Commissioner Judge has been personally involved in the access issue since prior to and during the REG-NEG process. His travels to DC on this issue have been numerous.

Mr. Derb Carter, representing SELC, Audubon and DOW quoted their typical misleading information with fuzzy science attached while NPS representative Herbert Frost quoted the NPS

statement opposing passage and misrepresented the timing of the SELC lawsuit.

A strong supporter of S.2372 was found in committee member Joe Manchin (D - WV). Senator Manchin admonished the NPS (represented by Mr. Herbert Frost) for becoming both an "adversary" and an "enemy" of the people of NC. "The majority of the people who live there are totally in favor of 2372," he said, "and those who have filed lawsuits do not live there. Don't you consider the people who live there and their livelihoods".

With Senator Manchin's support we will need at least one (1) more Democrat to vote in favor of this bill in order for it to move out of committee, thru mark-up and on to the Senate floor for a vote. Our membership from WV and their fellow citizens have shown how personal contacts can

make a difference. Now we need the support of everyone to contact their Senators and members of the Energy and Natural Resources, request their help in moving this bill forward. While they argue budgets, remind them that this legislation requires no additional funding while the NPS plan requires a minimum additional expense \$1.4 million per year plus the required infrastructure (their associated costs, conveniently have not yet been estimated by NPS).

Nominations, Elections and BOD Appointments

The NCBBA Constitution & Bylaws was revised & approved in May, 2011.
ARTICLE V BOARD OF DIRECTORS
 A. Nominations. At least forty-five (45) days prior to the election, the President, with the concurrence of the Board of Directors, will appoint a member to serve as chairperson of the Nominating Committee. The chairperson will, in turn, name at least two (2) additional members to serve with him. At the September 1, 2011 BOD meeting I appointed Director Ron Saunders as Nominating Committee Chairman. An Article requesting the membership to submit their resume & photo ran in the Oct. / Nov. / Dec. edition of the newsletter.

The function of this committee is to prepare a tentative slate of officers and directors for presentation to the Board of Directors for its approval. No members outside the current BOD submitted a resume by the January 9, 2012 deadline. At the January 14th BOD meeting the decision was made to reopen the nominations. This was announced in the Jan. /Feb. /Mar. edition of the newsletter.

B. Voting Ballot. After the acceptance of the slate of officers and directors, the Board of Directors will instruct the Nominating Committee Chairperson to prepare an official ballot, which will include a provision for members to vote by proxy. Electronic ballots, if used, will reflect the same information as that provided on the hard copy ballots. Ballots shall be mailed and/or made available on the internet to each member at least thirty (30) days prior to the election.

At the March 24th BOD meeting Nominating Chairman Saunders presented the BOD with a slate of officers and directors for BOD approval. It was voted & approved at this meeting. On April 13th the Official Election Ballot was available on the website and voting began.

Our newsletter printer suddenly stopped production & closed up the end of March leaving Editor Mike McNichol scrambling to find another printer to handle this edition.

The electronic version was sent to members on April 23rd & everyone else received it by mail the first week of May. While it is unfortunate that not everyone received the newsletter 30 days before the voting ended, the ballot was available to the entire membership on the website.

Write-in nominations from the floor by any member in good standing will be accepted. The tallying of votes for the officers and directors will include such nominations. There were no nominations from the floor and election balloting was closed. The following were elected to serve a 2 year term:

The NCBBA Constitution & Bylaws
ARTICLE V BOARD OF DIRECTORS
Section 2. Officers and Directors

The officers of the NCBBA will include a President, a Vice-President, a Secretary and a Treasurer.

An officer cannot hold more than one position simultaneously except the offices of the Secretary and/or Treasurer. The offices of Secretary and Treasurer could be filled by one person, if the Board of Directors determines it is necessary.

Section 7. Vacancies

Any officer's or director's seat which becomes vacant for any reason may be filled by the Board of Directors to complete the term vacated. The Secretary's and the Treasurer's positions must be filled within thirty (30) days after the vacancy occurs. The President's position will be filled immediately by the Vice - President.

During the June 9th BOD meeting, in accordance with the NCBBA Constitution & Bylaws, the BOD appointed Secretary, Dottie Broadbent to also serve as Treasurer while the semi-annual audit is completed and a permanent treasurer is found from among the sitting BOD or a member of the Association. Anyone interested in the treasurer's position, please submit a resume with your qualifications & why you wish to serve NCBBA to Nominating Chairman, Director, Ron Saunders. Please send this information along with a picture (ID card type) as attachments to e-mail. Send to ron.saunders@ncbba.org. E-mail only please as this capability will be a requirement for the office holder.

In addition, Ashley Mintz #14455 has accepted a BOD appointment to complete the unexpired term of former Director, Dave Gresens. This position will be among the 4 Director positions up for election in 2013.

Treasurer Beverly Cox was absent so there was no treasurer's report at this time.

Director Mike Metzgar emailed out to the BOD the voted and passed budget report.

Director Metzgar also reported on the internet and website. Once the new database is completed the organization can be launched into allowing members and membership to make the necessary changes to their personal information. One of the changes to the new database was to streamline the whole system of the usage of PayPal so that the treasurer and/or President will not have to physically approve an order. Now membership and merchandise will have instant notification about payment and orders and can be shipped immediately. Another change was to process the photos submitted for the Photo Contest onto the website at Director Mowers request. This way those that submit pictures can see their photos first hand on the website.

Regarding scholarship's the dates, times and locations have been sent out to the board. Vice President Tom Burke will be presenting the scholarship in Manteo, Secretary Broadbent will present First Flight and Treasurer Beverly Cox will present Cape Hatteras. Director Metzgar will provide the forms and certificates for the nights of presentation.

Vice President Tom Burke reported on the Fishing Tournaments. A number of members have sent in request to fish the upcoming Ocracoke Tournament.

There was nothing to report on Business Practice at this time.

Since VP Burke will be leaving the board after the next election he suggested that everything is going to be automated and the business practice duties be added into Director Metzgar's director duties.

On Fishing Citations at this time only 12 member citation forms had been received.

Director Rod Palmer reported on the Operation Beach Respect and Adopt A Hwy. Permits have been received with a few corrections made to them. There currently is a low numbers of volunteers for this event. Several ramps have been closed, this might be the reason for a low turnout.

Director Mowers gave her report on membership. A report on the numbers on membership was emailed out to the board before the meeting. Records show new membership is up from the previous month. Membership has attended the Great Bridge Fishing Club tackle swap and will be at the Mid Atlantic Saltwater Fishing Expo in Richmond, Va. next weekend with 20 members volunteering to help out.

There was nothing to report on the Photo Contest at this time.

For The Achiever of the Year award member Jeanne Griffin #13555 is holding the lead.

Director Laura Etheridge presented her report on merchandise. Sales have picked up from the winter months. At this time she presented to the board the new design for 2012 merchandise. The new logo states "United We Stand Divided We Fail". With a large number of left over 2011 merchandise still available there will be a push to sell these shirts in the coming months.

Director Pete East had his report on Public Relations. All local newspapers were notified about the upcoming OBR and AAH. There was also a picture published in the Coastland Times of the current board with names and positions.

Director Mike McNichol gave his report on the Newsletter. The printing company that the organization had been using suspended operations. The new printing company is ATL Printing. Arrangements have been made to find a new typesetter for the newsletter to be available to be sent to the new printers. One upside of the new printing company is the cost of the newsletter will be less than before.

There was nothing to report on fundraising at this time.

Past President Jim Keene reported on CHAPA. There is a bill currently in Congress submitted by Rep. Walter B. Jones. Basically the bill states to stop the current rule as written and return management of the park to the intern plan that was in place prior to the final plan and renegotiate a new ORV rule. There are currently three co-sponsors of the bill and everyone is being asked to support and sponsor bill #4094. The bill currently resides in two separate subcommittees. One being the judiciary committee because in the lawsuit it challenges that the NPS instituted rules without due process, violated the NEPA act, violated paperwork protocol and operating this rule was not followed the proper way. The rule was written with total disregard to the rules of operation that were put in place.

Now it is more important than ever to obtain members email addresses for this is the cheapest way to get this information needed out to the general public. The problems we are having here at Cape Hatteras National Seashore Recreational Area are on a national level.

Director Metzgar reported on UMAP. The next scheduled UMAP meeting is May 5, 2012 at the Cape Hatteras Anglers Club and is being co-sponsor by OBPA. Board members attending the

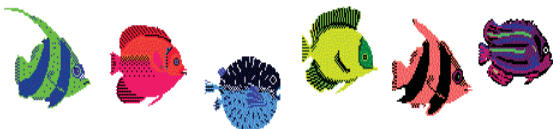

Beach Access Legislation Passes in the House of Representatives

In a historic legislative move, the U.S. House of Representatives has passed H.R. 4094 to restore reasonable access to the Cape Hatteras National Seashore Recreational Area. The bill, introduced by Congressman Walter Jones, was approved Tuesday, June 19, 2012 and passed in a 232 to 188 vote.

H.R. 4094 was included in a package of bills grouped together under H.R. 2578, known as the Conservation and Economic Growth Act. The bill would reinstate the Interim Management Plan that was in place prior to the restrictive consent decree and ORV Rule implemented by the National Park Service.

The 2008 consent decree imposed rigid and severe beach access restrictions that have hurt the local economy and limited the Superintendent from utilizing an active management approach that would better help wildlife at the seashore.

Chairman Warren Judge, who testified before a Congressional Subcommittee urging the passage of H.R. 4094, described the significance of today's vote. "The House of Representatives has passed a landmark piece of legislation," Judge said. "It will provide reasonable recreational access in a way that utilizes science based resource management for shorebirds and turtles." Judge added, "H.R. 4094 represents a true win-win situation, for both people and wildlife."

Vice-Chairman Allen Burrus thanked Congressman Walter Jones and his staff for their efforts to get House passage of H.R. 4094. "They did the right thing for the people of Hatteras Island and the businesses that have suffered for too long," Burrus said. "My hope is that this will be a stepping stone to pass similar legislation in the U.S. Senate."

A companion bill has been sponsored in the U.S. Senate by Senator Richard Burr and Senator Kay Hagan. Senate Bill 2372 will be the subject of a Congressional Hearing next week.

Dear Representative:

In light of the expected vote next week on H.R. 2578, The Conservation and Economic Growth Act, we are writing to express our strong support for Title X: The Preserving Access to Cape Hatteras National Seashore Recreational Area Act. This provision mirrors language from H.R. 4094, a bill to reinstate the Interim Management Strategy governing off-road vehicle (ORV) use in the Cape Hatteras National Seashore Recreational Area, which passed the House Natural Resources committee on June 7, 2012. The park's recently implemented final ORV rule is severely restricting public access to one of the East Coast's most popular surf fishing areas and causing dire economic impacts to the local community. This legislation is needed to provide relief to this community by requiring the park to be managed under the Interim Management Strategy until a more reasonable and balanced final ORV plan is developed.

The sportfishing industry and anglers are true conservationists who directly invest in the conservation and management of fishery resources and care about the conservation of our nation's natural resources - including those at Cape Hatteras National Seashore Recreational Area. We believe strongly that reasonable access to the beaches can be provided for ORVs while protecting nesting shorebirds and other wildlife. The final ORV management plan currently in place severely restricts access to the most popular areas of the seashore far beyond what is needed for fish and wildlife resource management. In implementing the final ORV management plan, the Park Service ignored the numerous comments of the sportfishing community and local residents. This plan is the most restrictive management plan to date and not only threatens sportfishing in the park, but the seashore's local economy, which is largely dependent upon tourism and recreation. The Preserving Access to Cape Hatteras National Seashore Recreational Area Act will reinstate an interim management strategy that underwent the appropriate review process, restoring reasonable ORV and pedestrian access while providing appropriate shorebird and resource protection.

On behalf of the nation's sportfishing community, we respectfully request that you support this important legislation.

I asked NPS for a permit waiver for tournament participants and this request was denied. Everyone who drives on the beaches of Cape Hatteras National Seashore Recreational Area

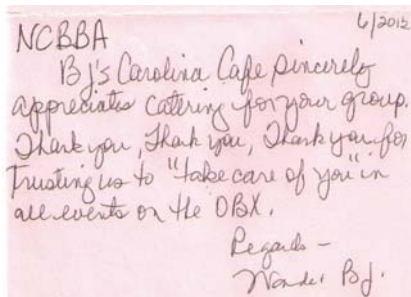

Depending on the draw, some judges are scheduled to do an additional 4 hour shift Saturday afternoon. At least 30 people are needed for these positions.

Fishing Report

by John Newbold, Fishing News, #14



Although surf fishing is what most of us really love most, there has really been little happening. We have had a mild spring, but fishing by species has been in short spurts. Bluefish were plentiful in the surf through May and into June but have slowed down now. There were also quite a few in the eight to ten pound range caught on the southern beaches; Billy Mitchell, Hatteras Inlet and Ocracoke beaches; but that too, has slowed.

Blow toads made a short but strong appearance, but again, did not stay around long. Sharon and I had one excellent day where we caught thirty-five or so, but that's been it.

Sea mullet, too, have not been plentiful, but many of the ones being caught are quite large, with a few topping two pounds. Most of these fish are being caught on sand fleas being fished very close to the beach. These tasty guys are still around as I write this, so all is not a total loss.

Flounder are now being caught in the surf and are hanging out close to shore in the first slough. Fish to twenty-two inches have been caught. Live mud minnows or a squid strip are best bets for these guys and T. W.'s in Nags Head carries live mud minnows or gudgeons.

Cobia have arrived and are mostly caught here by boats sight-casting either live eels or jig heads tipped with feathers and/or a squid strip. About three weeks ago I personally watched a lady land a seventy-five pound fish in the surf. The fish was gaffed by her friend and she wound up about one-fifth on a mile from where the hook-up occurred. Talk about a blast from the beach, it doesn't get any better! These fish are mostly caught in boats in deeper water, but they do venture close to shore. Best bait for these guys is a live eel.

The start of the pompano run is in full swing. Water needs to be warm and clear to really have a good day with this species, and the larger fish are mostly caught from the Billy Mitchell ramp down to Hatteras Inlet. Ocracoke also produces good catches of this species. Sharon and I caught huge pompano in Destin, Florida this past winter and I learned to tie the rigs locals used there. Use fluorocarbon line with gold kale hooks and fish as close as you can to outer bars in and near white water.

Trout fishing here has been excellent this past spring, but most fish were too small to keep. Catches of thirty to forty fish per angler are common, but again, most are not keepers. Best spots have been

behind Bodie Island lighthouse, Little Bridge by Fishing Unlimited on the causeway to Manteo, and by the many grass islands behind Wanchese in the sound (need a boat for these guys). Double jig-heads with Gulp baits work best, but mud minnows are a sure bet too.

Near-inshore boats have had good catches of cobia, blues and large spanish, while the off-shore fleet has had great yellowfin and gaffer-size dolphin fish. Boats wreck fishing have done well with black bass and nice catches of triggers (fun to catch, great to eat, and a pain in the ​@#Ë to clean).

Lastly, there have been almost no catches or even reports of catches of puppy drum! Earlier in the season, large drum were taken at Cape Point by the hard-cores who had to walk nearly a third of a mile in the water to get to the Point which was closed to vehicles because of some bird that was suspected of laying an egg. Other than that, no puppy drum at all. Beach closures have played into the problem, but I'm really concerned that we will have a bad class-year for this favorite species.

I'm sure by now you know you will need a beach vehicle permit to access the National Park, and that the area we can access is now about twelve or so miles, and no more. These closures are not just a local problem, but a national one. Cape Hatteras is a National Park and was established as a recreational area. The current superintendent has taken much of this away from all citizens everywhere. I urge you to voice your complaints to your local state senators and congress men and women so that we may all reclaim our beach to enjoy as we always have.
