# Secretary's Report: Highlights of Board Meeting: November 23, 2013

In the absence of President Dave Joyner Vice President Rod Palmer called the meeting to order at 8:07AM.

He welcomed guest members Patti Metzgar #12340, John Cupples #12650, Ed Wilk #14796, Dave Wigginton #335 and Rich Donner #14740 to the meeting.

Secretary Dottie Smith at this time asked that time minutes from the September 28th, 2013 meeting be accepted as written. Vice Pres. Palmer made the motion to accept the minute as written, this was seconded by Director Harry Nash and the motion was passed. Treasurer Tom Heggie presented the Treasurers and Financial Reports.

A motion was made by Past President Jim Keene to accept the report, this was seconded by Director Bill King and the motion was passed.

Director Mike Metzgar reported on the Internet/Website. President Joyner had asked Director Metzgar if there was a monthly maintenance plan that the organization could possibly get with the Link Corp. to maintain the daily operations of the NCBBA without getting overcharged every time an item needs attention to. This way it can be added to the 2014 budget plan. Two solutions were offered for the organization but none of the solutions would really work well for what is needed or benefit in anyway.

Director Metzgar is in touch with Link Corp. also on the issue of posting pictures on the

website. It is planned for Link to get in direct contact with Director Pam Smith to help rectify this situation.

Director Metzgar reported on the Scholarship program. At this time there are 15 students receiving scholarships from the organization. Even with the adding of Ocracoke last year it is still the most recorded amount since Director Metzgar took the program over.

Director Bill Smith reported on the Fishing Tournaments. It was a good year for the NCBBA Fishing Teams. For the Cape Hatteras Anglers Club Fishing Tournament the team was led by Director Mowers had some hard fishing conditions but came thru with a 4th place finish overall out of 120 teams.

Director Smith asked that the member application for fishing on the NCBBA team be available on the website.

Director Smith reported that there have been 21 citations received as of this time.

Vice President Palmer reported on Operation Beach Respect and the Adopt A Hwy. program. He wanted to thank everyone who helped out with the last OBR, AAH and Year End Cookout.

Member Jim Wilson #10381 wants to volunteer overseeing the organizing of volunteers for the A.A.H. events with the help of Director Mowers. After the BOD discussed this issue it was decided that Director Bill king will be organizing the O.B.R.'s from now on. The board members whom are assigned

Weigh Stations were asked to stop by those tackle shops and pick up the totes to have them restocked and organized.

Secretary Smith reported on Merchandise. Sales are about average. A new logo for 2014 is being sought. The hunt is on for a new supplier for the reel jackets. Director Metzgar will contact the member who made flags recent as raffle prizes at the Red Drum Tournament.

Director Mowers reported on Membership. New membership is down for 2013. After deletion notices were sent out some members retained their membership so the notices she feels is benefitting the organization. At this time there are 4150 active members. There are 2942 regular members, 1160 life members and 48 junior members.

Director Mike McNichol asked the question "what does a card carrying member get with that card?" Director King has developed a similar program and has offered to help another board member move this forward.

Director Mowers has 10 members so far with credits toward the Achiever of the Year Award.

Director Pam Smith reported on the Photo Contest. At this time there are 10 entries. She will organize a committee to judge the submitted photos. December 12, 2013 is the deadline.

Director Harry Nash reported on Public Relations. Wanted to remind board members that the more pictures and info on upcoming events he has the more info he can get out in local newspapers and radio stations.

Director McNichol reported on the newsletter. There is a deadline of December 15, 2013 for the next newsletter. There had been concerns of the type being too small for most to read. Director McNichol will be working with the printers to resolve this problem.



On Monday they were scheduled to go out on the F/V Country Girl but with the winds blowing 30+ mph. that was cancelled and since the Fish Fry the next day was depending on the fish caught on the trip, Life member Mike Kelly #524 offered the fish for the fry to be purchased wholesale with the proceeds from the ticket sales and for it all to be cooked at his restaurant "Pamlico Jacks' in Nags Head. Tickets for the fish fry were oversold and many were bought merely as a donation to the event and had no intention of attending but wanted to donate anyway they could. Five Warriors were able to attend with one that had to leave a day early due to medical reasons. A truck equipped with a driver and complementary fishing gear was available to each Warrior. Not only said it was more than ok but supplied the event with a blanket beach driving permit. Even though it was applied for in July the N.C. Wildlife Commission supplied a blanket fishing license for all the Warriors the week of the event. The following day after the cookout and fishing on the beach they all went to the N.C. Aquarium on Roanoke Island and then over to the new Jennette's Pier to finish off the event. The NCBBA had special hats made for all the participants and donations from Food Lion, Harris Teeter and individual cash donations made this all possible. But it was the donation from the VFW #4809 Ladies

Auxiliary of Norfolk, Va. that made a huge impact on all. With all the other donations the VFW donation was not really needed to supply any of the events. So the NCBBA decided to take the \$500 donation and give it to the five Warriors who attended so they had something other than the memories to take home with them.

For the Directors positions there are Director Mike McNichol,Life Member Ed Wilk #14796, Life Member John Cupples #12650, Member Brian Trotter #12373, Member Al Adam #13459, Member Charles Lockett #12383 and Member Dave Wigginton #355.

On the 50th Anniversary Celebration Past Pres. Jim Keene confirmed the date of October 4th, 2014 at Kelly's Restaurant in Nags Head, N.C. The event time will be from 6:30-10PM. Food will be heavy hors d oeuvres, beer, house wine and in addition a cash bar will be available. It is projected to have 250 members and guest attending. The restaurant has also supplied the names of three to four bands that usually play the bar and can continue to play there the evening after the party. Commemorative pins are being ordered for those attending to keep after the event.

Past President Keene and Director Bill Smith discussed with the board where the \$1,000 gift donation from State Farm insurance was distributed to. To the Hatteras Island Water Rescue a \$500 gift donation was made during the Red Drum Tournament. The remaining \$500 went into the general fund.

A motion was made by Vice President Palmer to close the meeting, this was seconded by Treasurer Heggie and the motion was passed. Meeting was adjourned at 11:35AM.





# **Fishing Report**

In my last Newsletter, I talked about the fact that the fall puppy drum season was getting underway, and did it ever! As I am writing this report on January 10th., Buddy Branner #12063 and his wife Marcia called to tell me they had already caught two puppy drum before noon. They were fishing at Oregon Inlet which has produced one of the best seasons on this species I can ever remember. Holes to the north and south of the ramps have produced fish since mid October with an apparent no end in sight. Things have slowed since before Christmas when a good day would produce ten to fifteen fish landed and four or five pulled off. Tides would vary. Some days the outgoing was best and other days fish were caught ton the incoming water. Best bait was fresh mullet. but as that bait got harder to find, shrimp worked as well. Most fish were inside the outer bar, so long casts only put thou past the fish. And again, the double dropper loop

with 5/0 circle hooks proved most effective. Most hook-ups resulted in the fish coming to the beach, which made utter chaos for anglers fishing more than one rod. And yes, most every fish was in the slot, eighteen to twenty-seven inches, with most fish measuring between twenty-two and twenty-four inches. Photos of catches flooded websites and my personal best day was twenty pupples and one twenty-three striper!!

Cape Point has also been very productive on drum with flounders mixed in and puppy drum are being caught there as I write this article. Expect more people fishing there and expect to get fussed at for using braided line. The 'hard core locals' mostly fish mono and can get pretty vocal if their line is cut by an angler using braid. Just use good judgement when fishing there and respect others.!

As far as other species, bluefish were almost nonexistent. It was truly the first fall season I can recall that did not produces

catches of bluefish, and no one I've talked to seems to have an explanation or reason for this.!

Speckled trout were caught all fall, but there were no sustained bites of large fish. Best catches were in the sound and north of the Kitty Hawk and Avalon piers. Gulp baits and double trout jigs did the job here.

Once again, on a sadder note, I'm sorry to report the passing of two friends of mine. Charlie Evanowski #515 passed away in late fall after a rather long illness. Charlie was best known for his sly and secretive ways when he fished, and he most always had the

largest fish in one or more species to turn in at all the individual tournaments. His wit and dry sence of humor will be missed by me for sure, and I know others will agree!

Former member Marvin Breiholz passed away the last of December after a short but serious illness. He was a mainstay on the Crooked Hooks Surf Fishing Team. Marvin had an infectious grin and a smile that spoke out loud for the fun he enjoyed during tournaments and recreational fishing. ### Where the Money Goes




Most of you have no doubt wondered what happens to the money you pay for the privilege of beach driving within Cape Hatteras National Seashore Recreational Area. Like you I expect some return for monies I expend so I have twice asked for this information. (Your \$50 - \$120 stays within the Seashore for purchases and is not sucked up by the great vacuum in DC.) In early 2013 a very general answer was given to David Joyner, Harry Nash & I in a meeting with the Superintendent & Assistant Superintendent at their offices in Manteo. In November 2013 I formally requested a detailed report of expenditures of OV Permit revenues as well as a detailed budget for expenditures in FY 2013-2014. Following is the reply received from Superintendent **Barclay C. Trimble:**

Thank you for your November 3, 2013 letter regarding the Off-Road Vehicle (ORV) beach driving permit revenue at Cape Hatteras National Seashore (Seashore) for 2013. Unfortunately, with requirements associated with implementation of a new financial system last year, the governm shutdown, and a mandatory financial blackout for the month of November, we just recently obtained access to the financial information that you requested. I appreciate the opportunity to reply to your request and hope that you find the following useful.

As in last year, all permit revenue generated from the sale of beach driving permits remained at the Seashore to help offset the costs of implementing the ORV Management Plan (Plan) and providing visitor access. Permit revenue was not utilized to meet the operational needs of other parks or their

Permits were sold over a partial Fiscal Year in 2012 (February 15 through September 30), which generated \$1.88M in revenue. Expenditures during that year focused on establishing a permit program, hiring limited numbers of staff, maintaining or improving operational capacity, and contracting for parking improvements. The Seashore did not fill all of the positions or initiate any new infrastructure projects that were identified within the Plan.

In Fiscal Year 2013 (October 1, 2012 through September 30, 2013), permits were sold for an entire twelve month period, which as you would expect generated more revenue, which also increased the volume of expenditures. A total of \$2.089M was collected in 2013. Expenditures occurring this year included elements such as managing the issuance of permits, hiring and managing staff, completing the Environmental Assessment (EA) for the access projects identified in the Plan, maintaining operational capacity by purchasing equipment and supplies, providing informational services, and initiating construction on projects identified in the access EA

Below are the details associated with these broad categories and the amount of revenue that we expended for each group. Totals do not amount to the total revenue received due to rounding.



#### Payroll (\$1.065M)

- 12 Visitor Use Assistants (permit staff)
- 4 Protection Rangers (patrol rangers)
- 3 Heavy Equipment Operators (staff maintaining ramps, parking lots, etc.)
- 4 Beach Access Information Rangers (rangers providing daily ORV information to beach users)
- Research Coordinator (staff to identify and obtain research as required by the Plan)
   Media Specialist (staff developing and maintaining accurate ORV information for the Internet, social media, Google Earth, etc.)

#### Remaining Balance (\$1,500)

The Seashore was unable to expend this revenue due to Fiscal Year closeout deadlines and revenue deposited after established contracting/purchasing deadlines.

The permit revenue did not cover many of the costs associated with managing the Seashore's ORV program such as the majority of law enforcement and resource management staff costs, permit office rental, costs associated with managing the Public Access EA, fuel, and more, which were funded from the Seashore's congressionally authorized budget and were estimated at more than \$2.823M.

#### 2014 Beach Driving Permits

The Seashore anticipates that beach driving permits will generate revenue in an amount similar to 2013 and consequently purchases are expected to be associated with continued management of the ORV program. With completion of the access EA, the Seashore is planning to use as much permit revenue as possible to fund those infrastructure projects identified in the Plan and prioritized using public input obtained during the development of the EA. Some projects are expected to be accomplished using permit revenue, but some could be accomplished using existing staff and equipment or alternative fund sources as available.
